2013 South Walton Tour of Homes

Benefiting Alaqua Animal Refuge

I. gall & company, in conjunction with Alaqua Animal Refuge, announces the **2013 South Walton Tour of Homes** featuring eight exquisite South Walton homes. The inaugural event will be held on **Saturday, May 18 from 10 a.m. to 4 p.m.** for those whose love of art, interior design, landscaping and architecture will be rewarded with the self-guided tour.

Eight distinct and diverse homes and condos, from Miramar Beach to Rosemary Beach, will be selected and featured on the tour. The proceeds from the self-guided annual tour **benefit Alaqua Animal Refuge** and Alaqua's Unleashed Dog Park, both located in Walton County.

SUBMISSION CHECKLIST

This information must be completed and submitted with your application for each home submitted.

Eligibility and Authorship:

All submissions shall depict homes located in the South Walton area – Miramar Beach to Rosemary Beach. Condos and Penthouses can also be submitted for consideration. The home/unit must be complete at time of submission and must be of a size and design appropriate for the event. The Committee selects finalists which appropriately represent the variety of interior design services and architectural styles offered in our area. Entries must be completely constructed and furnished at the time of viewing. The opinion of the Committee on whether the entry will be substantially complete by the Tour brochure publication date (approximately one month before the Tour) determines eligibility. A maximum of three homes from any one interior design firm or entrant (independent designer) may be submitted. The Committee will select blindly and not be privy to which interior design firm or designer is responsible for the design submission to ensure fairness.

Entry Deadline:

Submissions must be delivered by **6:00 pm on Friday, March 29**. No late entries will be accepted. Each submission must be available for viewing by the Committee during a two-week period immediately following the submission deadline. The Committee will review the submissions and determine the Tour participants by April 10, 2013. All entrants will be promptly notified of the results.

Submission Requirements:

All submissions must be submitted in digital format via email. Submissions are to include:

1. A 250-word-or-less written description of the project to facilitate the selection process,
2. 8-10 high resolution photos of the home and the interior design elements (minimum 300 dpi) Acceptable file formats are jpeg and tiff. At least 2 photos must be of the exterior of the home. All must be sent packages together in a zip file.
3. The street address of the home and name of the property owners.

4. Written authorization from the owner that the submission will be available for viewing on the tour date.
5. Completion of the submission checklist on this call for submissions.

Additional Criteria:

1. No homes will display "for sale" signs during the home tour.
2. No homes will be selected that are in a gated community.
3. Interior designers will be onsite the day of the tour to help facilitate the touring of their selected home.
4. Homeowners will cordon off areas in the homes that they do not wish to be available to the public.
Cordons must be attractive and in accordance with décor and/or design of home.
5. Geographic proximity to other entries will be considered as selection criteria.
